# Direct an International Organisation, manage its Secretariat and activities:

With over 15 years of experience in leadership roles, I have developed a deep understanding of the operations of prominent Membership based international organisations like the EPB (European Polar Board) and SCAR (Scientific Committee on Antarctic Research). My roles have given me extensive knowledge and experience in providing Secretariat support for international organisations and their meetings, managing Secretariat staff, managing organisational finances and audits, overseeing communications, and implementing Members' vision, objectives, and activities. Prior to my role in SCAR, I have also worked with the University of Cambridge (UK), the Naval Materials Research Laboratory (India), and the National Environmental Engineering Research Institute (India).

In 2025, the EPB has 31 Members (from 22 European countries) that include research institutes, logistics operators, funding agencies, scientific academies and government ministries from across Europe. Under my leadership, the EPB welcomed 10 new members (from 21 to 31 currently), thus increasing our core funding substantially by ~25%. EPB holds two Plenary meetings per year, generally hosted by Member organisations. EPB's activities and Secretariat are primarily funded by Member contributions, other voluntary contributions by Members, and EU-funded projects. I led the provision of Secretariat support by organising EPB meetings and collaborating with local hosts. I ensured that all information and working papers relevant to the meeting agenda are prepared and available on time. I worked closely with the Chair and Executive Committee to ensure everyone was well briefed during meetings, facilitating efficient note-taking and timely distribution of meeting reports afterwards. Further, my responsibilities included management of EPB Finances - including managing income and expenditures, provisional financial reports, provision of budgets and forecast budgets, to the EPB Plenary, annual accounts for the Netherlands authorities, and working with auditors for regular external audits of EPB finances. EPB's status in the Netherlands as a not-for-profit "Organisation of Public Benefit", which comes with added responsibility for financial transparency and reporting. This is similar to EuroGOOS' status as an AISBL in Belgium, with broadly similar administrative requirements.

As head of the EPB's Secretariat, my responsibilities included **representing the EPB at various fora, being the central point of contact for the EPB** (both for internal Member enquiries, and for external contacts seeking information regarding the EPB). I led the EPB's communications requirements, and with the Communications Officer, provided input to all aspects of communications including, the EPB website, newsletters, white papers & other publications, EPB's communications related deliverables, EPB's YouTube channel and webinars.

Staff management, HR: As part of my administrative and supervisory responsibilities so far, I have recruited and managed staff time in small offices for more than 15 years. In 2023-24, EPB staff totaled over 20, including permanent staff, consultants, visiting professionals, and volunteers. I have always built trust between staff and ensured there is effective delegation of work, this, I feel is particularly important in a small and busy office environment. I have also ensured any employees I manage get continuous professional development as required, and are provided with mentoring, and further support if requested. Over the course of my career to date, I have hired and supervised more than 100 professional, administrative, technical and voluntary staff, being balanced in gender, and represented a very wide diversity in country of origin, and professional backgrounds. My leadership and mentoring abilities have been recognised through APECS awarding me the 2017 International Mentor award. My collaborative leadership style, combined with my commitment to inclusivity and capacity building, aligns closely with EuroGOOS's multicultural and interdisciplinary approach. I am eager to bring this ethos to advance EuroGOOS's mission.

Finance management, Fundraising and Strategic vision: Awareness of political issues and sensitivities is a central need for success in any position at a globally recognised organisations like SCAR and EPB. I represented the EPB (and SCAR previously) in public fora, and have successfully reinforced its European and international recognition. These external networking and communication activities have directly resulted in the invitation for the EPB to participate in 6 very large EU funded projects (total funding ∼€60 million) and a substantial increase in EPB's annual

income. Having participated in these projects as WP lead and as a part of Leadership/Steering Committee, I am thus experienced in all stages of the externally funded project lifecycle, including setting up consortia, project conception and writing, budgeting, the post award work, both technical and financial reporting, and the final reporting, auditing post project closure. At SCAR, I was the Project Director, for the Martha T. Muse Prize, where one of my major successes was negotiating a significant increase to the administrative and management income for SCAR (3x), including a 5 year extension to the Muse Prize project for SCAR. As a founder of the Women in Polar Science (WiPS) network, which I manage on a voluntary basis, I have raised more than USD 150,000 (in cash and kind), which has helped to hire staff to manage and successfully implement various projects. My recent position at the EPB, (and my position at SCAR) had the responsibility for financial management - including oversight, budgeting and reporting expenditure (both current fiscal year and preceding years) as per organisational and host government needs giving me 15 years of experience in finance and budgetary management.

Outstanding Communication and proven ability to engage and influence a broad spectrum of Stakeholders: Over the last 20 years, I have interacted and worked with a very wide variety of organisational stakeholders – and well beyond topical polar organisations. My network of Stakeholders spans governmental organisations at local, national, regional and international levels, European organisations like the European Commission and European Space Agency; multilateral organisations like the IOC/UNESCO, UNFCCC, IPCC and WMO; OECD and their Governmental Foresight Community, the ATCM, Arctic Council and their subsidiary bodies like SAON, international NGOs like WWF, Greenpeace, and Universities like Cambridge, Oxford, and Coimbra, amongst many other organisations worldwide. I have extensive experience of interacting with stakeholders at all levels, including high level government ministers, ambassadors and other high-level functionaries, organisational and key opinion leaders. I regularly get invited to engage in advisory activities and committees, the results of which influence a broad spectrum of stakeholders, including government and international bodies - two recent examples include an invitation to Chair an organisational review of the International Arctic Science Committee, and an invitation to Chair a high level workshop organised by the Prince Albert II of Monaco Foundation in Feb 2025. Through leadership and coordination roles in EU projects, I have led, and Chaired and spoken at several policy briefings, and participated in the development of various white papers with a clear demonstrable impact on European policy, including Horizon 2020 and Horizon Europe funding calls. I have also led on the provision of advice to policymakers, including leading or authoring publications, some recent examples from 2024 are (1) White paper with recommendations to accelerate the development of a sustained and fully integrated Polar observing system; (2) Recommendations from Southern Ocean Carbon and Heat Impact on Climate. Such experiences both within Europe, and globally, uniquely position me for this position at EuroGOOS.

Organisational Transformation and Change Management: I have extensive experience in organisational transformation, via guiding the EPB through major changes between 2015-2017 as EPB sought to establish its own independent legal entity and developing all relevant internal regulations and bylaws. Further to ensure a clear organisational direction, I led the development of its first two 5-year Strategies. During my term at the EPB, I have also ensured that we specialise in a wide variety of communication platforms, and use a variety of tools like webinars. Prior to Covid, the EPB already had an established presence via webinars, and with the global closure of meetings, I was able to seize several extremely high-level opportunities for the EPB, like the webinar series organised by the EPB on behalf of the Governments of Iceland and Japan, for the Arctic Science Ministerial 3.

As EuroGOOS Secretary General, I would work with the General Assembly and the Executive Directors Board to further strengthen strategic partnerships, enhance organisational visibility, advance fundraising efforts, foster innovation and collaboration, and promote inclusivity and capacity building. My commitment to collaborative leadership, combined with my expertise in operational oceanography, strategic planning, and stakeholder engagement, makes me uniquely positioned to contribute to EuroGOOS's mission to identify priorities, enhance cooperation and promote the benefits of operational oceanography. While I'm fluent in English, I also have some knowledge of Dutch. I confirm that I am happy to be based in Brussels given this opportunity. With the completion of two terms at EPB, I am currently available for an immediate start from June 2025.

I led the European Polar Board (EPB), an independent organization uniting Europe's polar research organisations through multilateral collaboration. I directed the EPB Secretariat, represented European polar research in national, regional and global fora, and implemented EPB Members' strategic objectives by coordinating activities, convening experts, and organising events to advance polar science and policy. My responsibility was to champion EPB involvement in the wider polar sciences agenda with the broader polar sciences community in Europe and internationally, and support new opportunities to apply European polar expertise in other globally relevant areas like Observations, Data Science, Climate Change, etc.

## Key responsibilities and achievements include:

- Strategic vision with the ability to deliver organizational change: I led the establishment of the EPB as a legal entity (2015-2016) providing independence and stability. I initiated and coordinated EPB's first two 5-year strategy processes the first EPB Strategy 2017-2022, and the second Strategy 2023-2027. The two Strategies have ensured that EPB fulfils its mission to be "the Voice of European Polar Science" and ensured that it is strategically positioned to face new research challenges in the Polar Regions.
- Engage and influence a broad spectrum of international stakeholders at all levels: I have successfully built lasting partnerships with most national marine and polar programs worldwide, as well as a wide range of governmental and nongovernmental organisations (e.g. European Commission, European Parliament, OECD, European Space Agency, All Atlantic Ocean Research Alliance, National Science Foundation, Asian Forum for Polar Sciences, SCAR, IASC, SOOS, ISC). I lead EPB's participation in the UN Decade of Ocean Science initiatives, including taking a leadership role throughout the Southern Ocean Decade activities, and work closely with UN agencies (e.g., WMO, IOC/UNESCO) on long term initiatives such as the IPY 2032-33. I have also expanded EPB's networks with philanthropic organisations, the most recent being an MoU with the Prince Albert II of Monaco Foundation in 2024.
- Financial Strategy, Fundraising, Budgetary management: Since 2015, with a clear strategy and planning, I have driven a nearly 4x increase in EPB's total income, encompassing both core income from membership and external project-related funds, to ~€1 million. Under my leadership, the EPB increased core funding by welcoming 10 new Members (total Membership 31 in 2024). I oversaw the management of all EPB's income, future budgets, and accounting, ensuring compliance with organizational and national financial regulations. My fiscal responsibilities included leading internal and external audits, maintaining transparency in financial management as a non-profit 'Organisation of Public Benefit' (ANBI) in the Netherlands.
- Research project leadership: I initiated EPB's participation in large research projects from 2019, and played a leadership role in several research project consortia funded by national funding agencies, the European Commission, European Space Agency, and others, with funding for all projects totalling ~€60 million. I served as Work Package Lead for four projects, and as an invited Steering Board member for another two projects.
- Effective Line management of staff: I led and managed a diverse team in the EPB Secretariat a total of 11 employees, 4 visiting fellows, and 20+ consultants and rapporteurs between 2015-24. My focus while line managing staff, was on performance, professional development, and fostering an inclusive, positive work culture where open communication and feedback are valued, and ensuring that achievements of all are recognised. My approach has been instrumental in building a cohesive team that has consistently delivered excellence, even under difficult circumstances like COVID. In 2017, I was honoured to receive the International Mentorship Award from the Association of Polar Early Career Scientists (APECS), a recognition of my commitment and ability to guide, mentor, and empower individuals to reach their full potential.
- Science-policy communications: My leadership in the planning of the European Polar Coordination Office (EPCO) through WP6 of project EU-PolarNet 2, has now resulted in an independent EPCO based at the EPB from Jan 2025,

providing a direct link to European policymakers. I ensured that the EPB fulfils its mandates to represent European Arctic and Antarctic research communities and to provide evidence-based policy advice on issues affecting or affected by the polar regions through transparent processes: for example, by coordinating the EPB's International Cooperation Action Group and Policy Advisory Group. I led or coordinated several policy briefing events each year, with events in 2024 held at the European Parliament, European Commission and the European Space Agency.

# Feb 2010 to Dec 2014 Executive Officer, Scientific Committee on Antarctic Research (SCAR), Cambridge, UK

SCAR coordinates international scientific research in Antarctica and the Southern Ocean with more than 40 member countries across all continents. SCAR has observer status at, and provides scientific advice to, the Antarctic Treaty Consultative Meetings and other international bodies. SCAR meets every two years at the SCAR Delegates meetings, and organises several international conferences, including the SCAR Open Science Conference, the International Symposium on Antarctic Earth Sciences and the SCAR Biology Symposium.

### **Kev responsibilities and achievements include:**

- **Project Director, First SCAR Antarctic and Southern Ocean Horizon Scan meeting:** The Horizon Scan assembled the world's leading Antarctic scientists, policy makers, leaders, and visionaries to identify the most important scientific questions that will or should be addressed by research in and from the southern Polar Regions over the following two decades. This initiative remains arguably one of the most important activities undertaken by the Antarctic community in recent times. Numerous high profile journal articles were written, several of which I co-authored.
- **Project Director, Martha T Muse Prize in Antarctic Science and Policy:** As Project Director of the Martha T Muse Prize for Antarctic Science and Policy, a \$100,000 prize widely considered "the Nobel of the Antarctic", I successfully increased funds raised by more than 2x, ensured a diverse nomination pool, and particularly reached out to smaller polar programs to help build capacity for the nomination process.
- Communicating with other organisations in both the science and policy arenas: Building and maintaining working partnerships with both governmental and non-governmental organisations such as the Antarctic Treaty Consultative Meeting (ATCM) and the Committee for Environmental Protection (CEP), the Commission on Conservation of Antarctic Marine Living Resources (CCAMLR), Council of Managers of National Antarctic Programmes (COMNAP), ICSU (now ISC); coordinating the communication of Antarctic science and policy with organisations like the IPCC, UNFCCC and others.
- Managing SCAR Finances and staff: Management of internal income, external projects and grants including preparation of forecast budgets, statements of expenditure, financial reports, liaising with accountants and external auditors to carry out Audits; responsible for managing part of both Project Officer (aspects of co-ordinating SCAR meetings, and SCAR OSC Abstract system management in 2011-12, and finances in 2013-14) and Administrative Assistant (Muse Prize, Finance 2010 onwards), and managing volunteers and interns as needed.

WiPS have worked with a range of national and international partners, including research institutes, government agencies and universities in the global north and south. I have also led a successful fundraising initiative for WiPS, getting sponsorship from several organisations, both financial and in-kind, in total more than USD 150,000 to date.
